Guru Gobind Singh Jayanti: 16th January, 2016

Guru Gobind Singh Jayanti is a Sikh festival that commemorates the birthday of Guru Gobind Singh, the tenth Guru of the Sikhs. It is a religious celebration in which prayers for prosperity are offered.

Guru Gobind Singh was born in the year 1666 as Gobind Rai, to the ninth Guru of Sikhism, Guru Teg Bahadur (who gave his life to protect religious freedom of Hindus) and Mata Gujri, at Patna Sahib. According to Hindu calendar he was born on Saptami, Paush, Shukla Paksha, 1723 Vikram Samvat.

Noteworthy, Guru Tegh Bahadur the father of Guru Gobind Singh was publicly executed at the imperial capital Delhi in the year 1675 for protecting the Hindus against the religious fanaticism of the Mughals. Gobind Singh succeeded his father when he became a Guru at nine years of age.

Guru Gobind Singh's teachings have a big impact on Sikhs. In his lifetime, he stood against the Mughal rulers and fought against injustice against Hindus. In 1699, Guru Gobind Singh took five men from the lower



caste of society and baptized them as His Five Beloveds, endowing them with great courage and a devotion to God. It was his dedication to God, his fearlessness and his desire to protect the people from being oppressed that led Guru Gobind Singh to establish the Khalsa, a military force of saint-soldiers which he baptized.

Under Guru Gobind Singh's guidance and inspiration, the Khalsa followed a strict moral code and spiritual discipline. It was through his courage that the people rose against the oppression of the Mughal ruler in India at the time. Aside from being a spiritual and a military leader Guru Gobind Singh was also a gifted writer who penned a large body of literary work. Before his death in 1708, he declared the Guru Granth Sahib, which is Sikhism's Holy Scripture to be the permanent Sikh Guru.

Both Hindus & Sikhs celebrate this Jayanti and large processions come out in India on this day. People sing devotional songs during the procession and share sweets. Special prayer gatherings are also held at Gurudwaras throughout the globe.

First defence partnership under 'Make in India' signed

rime Minister Shri Narendra Modi visited Russia on December 24 & 25 to attend 16th India-Russia annual summit. This high level annual dialogue mechanism began after 'Declaration of India-Russia strategic partnership' signed by the then Prime Minister Shri Atal Bihar Vajpayee and Russian President Vladimir Putin in October: 2000. The declaration was political initiative between India-Russia relations after the cold war. Since then, regular dialogue mechanism operates at official and political levels to enhance



cooperation and follow up cooperative activities. During Prime Minister Narendra Modi's two -day -visit to Moscow to attend the annual summit the two countries signed 16 pacts to expand cooperation in various sectors.

During the visit India and Russia on December 24 signed 16 agreements across various sectors - including the manufacturing of nuclear reactors, solar energy plants, railways and the first partnership in defence manufacturing. "The agreement on manufacture of Kamov 226 helicopter in India is the first project for a major defence platform under Make in India," the Prime Minister said during his joint address with Russia's President Vladimir Putin."The pace of our cooperation in nuclear energy is increasing. We are making progress on 12 Russian nuclear reactors at two sites," he added.

While attending a meet of business leaders from both nations, PM Modi invited

PM Narendra Modi Lays Wreath At Soviet World War II Memorial

Prime Minister Shri Narendra Modi on 24 December laid a wreath at the Tomb of the Unknown Soldier, a war memorial dedicated to Soviet soldiers killed in World War II. The Prime Minister, braving cold weather, stood for a few minutes before the flame which



illuminates a bronze inscription that reads "Your name is unknown, your deed is immortal" at the memorial. A Russian military band played, as PM Modi laid the wreath at the memorial. The remains of the unknown soldiers killed in the Battle of Moscow in 1941 were initially buried in a mass grave of the Shtyki Memorial at the 40th km of the Leningrad highway at the city of Zelenograd. To commemorate the 25th anniversary of the battle, in December 1966, these remains were relocated to the Kremlin in the Alexander Garden in Moscow. The Tomb of the Unknown Soldier was designed by architects DI Burdin, VA Klimov, Yu R Rabayev and sculptor Nikolai Tomsky.

Russian CEOs to invest in sectors like aerospace, infrastructure and diamond, and said his government has created a favourable environment to boost economic growth.

Pushing for upping economic ties, PM Modi and President Putin have agreed to institutionalize the CEO's Forum, with two meetings every year, one to be held in India and the other in Russia.

"As I look to the future, I see Russia as a significant partner in India's economic transfer and in shaping a balanced, multi-polar world," he said.

In his address, President Putin said, "India a great power carrying out a balanced and responsible foreign policy." Shri Narendra Modi wrapped up his two day-visit to Russia with an address to 3,000 members of the Indian community at Moscow's Expocentre.

Talking about India-Russia ties at Expocentre, the Prime Minister said "Political relations, trade relations is one thing. Our ties go beyond that."

Underscoring India's growing role in the international fora, PM Modi said, "Earlier India used to be a spectator. Today whenever the world takes a decision, India has a role to play... The world has now accepted what India has been saying on terrorism."

Earlier, at a joint media

conference with President Putin, PM Modi announced the agreements signed between the two nations. "The agreement on manufacture of Kamov 226 helicopter in India is the first project for a major defence platform under Make in India," he said.

President Putin said Russia plans to build at least six new nuclear power units in India over the next 20 years.

"Nature has destined us to work together. From hydrocarbons, our cooperation is moving to the hardest form of carbon -



Putin Gifts PM Modi Gandhi's Notes, 18th Century Indian Sword

Russian President Vladimir Putin presented Prime Minister Narendra Modi a page from the diary of Mahatma Gandhi and an 18th century Indian sword. President Putin presented the items to PM Modi while hosting the latter for a private dinner on Wednesday evening. "President Putin presented to the Prime Minister a page from the diary of Mahatma Gandhi. The page contains Gandhiji's handwritten notes" the Prime Minister's Office said in a statement. Vladimir Putin also gifted Prime Minister Modi a late-18th century Indian sword from Bengal province that features intricate silver artwork which belonged to the Najafi Dynasty.

In the joint media conference, both leaders said "we are working on logistics. Our Green Corridor project has taken off. The International North South Transit Corridor through Iran will significantly reduce transportation time and cost. We are moving forward on the India-Eurasian Economic Union Free Trade Agreement. This will also benefit us in Central Asia."

PM Modi inaugurates Afghanistan's new Parliament in Kabul

A section in Afganistan's Parliament premises named 'Atal block'

fter his visit to Russia Prime Minister Shri Narendra Modi arrived Kabul on December 25. In Kabul he inaugurated the Parliament building which was constructed by India at a cost of \$90 million. The Parliament building project was started by India in 2007 session of both houses of the Afghan Parliament after inauguration. PM Modi said that "nurseries and sanctuaries of terrorism" must be shut. "Terror and violence cannot be the instrument to shape Afghanistan's future or dictate the choices Afghans make," he said.



as a mark of friendship and cooperation to help rebuild Afghanistan. On the occasion he said that Afghanistan "will succeed only when terrorism no longer flows across the border", in a strong message to Pakistan which is often accused by Kabul of sponsoring the Taliban insurgency.

He was addressing a joint

PM Modi added, "There are some who did not want us to be here. There were those who saw sinister design in our presence here... But we are here because you had faith in us."

India has invested around USD two billion in aid and reconstruction in Afghanistan and trained scores of officers in the war-torn country.



"India is here to contribute not to compete; to lay the foundations of future, not light the flame of conflict," the PM told Afghan lawmakers.

Earlier, PM Modi inaugurated Afghanistan's new Parliament built by India. He said that he was "deeply touched" that a section in the Parliament premises was named 'Atal block' after former prime minister Atal Behari Vajpayee who turned 91 on December 25.

Upon his arrival in Kabul from Moscow on morning of 25 December, Prime Minister Shri Modi was welcomed with a warm hug by Afghan President Ashraf Ghani at the Presidential Palace. The two leaders later held delegation-level talks, discussing a wide range of issues, including on security.

Shri Modi also met Afghanistan's Chief Executive Officer Dr. Abdullah Abdullah and former President Hamid Karzai.

PM's stopover visit to Pakistan

While departing from Afghanistan on December 25 Prime Minister Narendra Modi tweeted "Looking forward to meeting PM Nawaz Sharif in Lahore today afternoon, where I will drop by on my way back to Delhi." Prime Minister Shri Narendra Modi stayed in Lahore for about two hours to wish Prime Minister Nawaz Sharif 's birthday while his way back to Delhi.PM Sharif and his family received Prime Minister Narendra Modi at the airport in Lahore.

The move was widely appreciated by intelligentsia world-wide. The Modi stopover in Lahore is being seen as departure from stereotypical protocol-driven diplomacy. PM Modi also participated in wedding of Sharif's granddaughter on the day.

External Affairs Ministry tweeted "After blessing the bride, PM departs Raiwind accompanied by PM Sharif who will see him off."

PM Modi held talks in the morning with President Putin to start the annual summit. The talks between the two countries have been taking place alternately in Moscow and New Delhi since 2000.

Earlier today, PM Modi visited the Tomb of the Unknown Soldier, a war memorial dedicated to Soviet soldiers killed in World War II.

He also visited Russia's National Crisis Management Centre or NCMC. A multi-level coordination centre, NCMC processes information from across Russia and monitors industrial facilities, crowded areas, tsunami threats and other natural disasters.

Assuring Russia that it is India's "principal partner" in the defence sector, Prime Minister Narendra Modi has said that the two strategic partners are working together for joint manufacture of advanced defence equipment in India under the 'Make in India' initiative. "Russia has been India's foremost defence partner through decades, accounting for a majority of our defence equipment... Even in the current environment, despite India's improved access to the world market, Russia remains our principal partner," PM Modi told Russian news agency Itar-Taas.

The Prime Minister said, "Indians will never forget the Russian support that we got when we needed it the most."

Last night, President Putin hosted a private dinner for PM Modi and held a tete-e-tete in Kremlin, during which the two leaders touched upon issues of mutual interest. "The meeting was fruitful," PM Modi tweeted later

Indian security forces foil terrorists attempt to dismantle strategic assets in Pathankot Air Force Station

The Indian security forces gun down six terrorists at Pathankot in Punjab. On receipt of intelligence inputs of a likely attempt by terrorists to infiltrate into military installations in Pathankot area, Air Force Station Pathankot was put on heightened alert status.

sensitive Technical zone where bulk petroleum and weapon storage areas were located and also where aircrafts were parked. After 15 hour battle a well coordinated effort by all security agencies including the Army, NSG, local police and Indian Air Force (IAF) succeeded in neutralizing the terrorists. The airbase

remained operational throughout and flights operated to and from the airfield during the period of engagement with the terrorists.

Immediately Pakistan Prime Minister Nawaz Sharif talked over phone to his Indian counterpart Shri Narendra Modi and promised action against the culprits of the Pathankot air base attack. It was first time Pakistan Prime Minister immediately dialed his Indian counterpart and vowed to take action.

On his talk to Pakistan PM, Shri Modi strongly emphasized the need for Pakistan to take firm and immediate action against the organizations and individuals responsible for and linked to the Pathankot terrorist attack. Specific and actionable information in this regard has been provided to Pakistan.

Prime Minister Nawaz Sharif assured Prime Minister Modi that his government would take prompt and decisive action against the terrorists.

Thwarting the terrorists's attempt to dismantle the Air base according to media report five Indian security forces bravely fighting lost their life. Prime Minister Shri Narendra Modi saluted the Armed Forces for successfully defeating the designs of the terrorists, and paid homage to the jawans who were martyred during the operation.

Defence Minister Manohar Parrikar congratulated the forces and said "They have done an excellent job containing these highly motivated terrorists".

'Stand Up India' – a boost to promote entrepreneurship among SC/ST and Women

he Union Cabinet, chaired by the Prime Minister Shri Narendra Modi on January 6 approved the "Stand Up India Scheme" to promote entrepreneurship among SC/ST and Women entrepreneurs. The Scheme is intended to facilitate at least two such projects per bank branch, on an average one for eachcategory of entrepreneur. It is expected to benefit atleast 2.5 lakh borrowers.

The expected date of reaching the target of at least 2.5 lakh approvals is 36 months from the launch of the Scheme.

The Stand Up India Scheme provides for:

- Refinance window through Small Industries Development Bank of India (SIDBI) with an initial amount of Rs. 10,000 crore.
- Creation of a credit guarantee mechanism through the National Credit Guarantee Trustee Company (NCGTC).
- Handholding support for borrowers both at the pre loan stage and during operations. This would include increasing their familiarity with factoring services, registration with online platforms and emarket places as well as sessions on best practices and problem solving.

The "Start up India Stand up India" initiative was announced by the PrimeMinister in his address to the nation on 15th August, 2015. The Stand up India component is anchored by **Department of Financial Services** (DFS) to encouragegreenfield enterprises by SC/ ST and Women entrepreneurs.

The details of the scheme are as follows:

- Focus is on handholding support for both SC/ST and Women borrowers.
- The overall intent of the approval is to leverage the institutional credit structure to reach out to these under-served sectors of the population by facilitating bank loans repayable up to 7 years and between Rs. 10 lakh

- to Rs. 100 lakh for greenfield enterprises in the non farm sector set up by such SC, ST and Women borrowers.
- The loan under the scheme would be appropriately secured and backed by a credit guarantee through a credit guarantee scheme for which Department of Financial Services would be the settler and National Credit Guarantee Trustee Company Ltd. (NCGTC) would be the operating agency.
- Margin money of the composite loan would be up to 25%. Convergence with state schemes is expected to reduce the actual requirement of margin money for a number of borrowers.
- Over a period of time, it is proposed that a credit history of the borrower be built up through Credit Bureaus.

He said the Indian Armed Forces were second to none, and now the time had come to ensure that the weapons and equipment they carried and used were also the best in the world. For this, he said, India needed to end dependence on imported weaponry, which is expensive

NDA govt. set off a mission to provide electricity to 18,000 villages

ndia has set off on an ambitious mission, mission to provide electricity to 18,000 villages which are still in darkness after almost decades of independence. Prime Minister Shri Narendra Modi, in his Independence Day speech announced that all remaining villages shall be electrified within 1000 days. Rural Electrification is happening at a rapid pace, and is being done in an unbelievably transparent manner. Data on villages being electrified is available to the public through a mobile app and a web dashboard. While we can observe only electricity reaching the villages, it is also important to note that it is accompanied by dreams, aspirations & upward mobility in life for the people residing in villages.

It is difficult to forget that one of the largest power outage in our history happened in India in July 2012, leaving 62 crore people in darkness. Such darkness engulfed the nation, even as more than 24,000 MW of generation capacity lay idle due to lack of fuel like coal and gas. The entire sector reached a vicious cycle of inaction and policy paralysis with surplus generation capacity and massive unutilized investments at one end while large power cuts for the consumer on the other end.

When the NDA Government came to power last year, as many as 2/3 of coal based power plants (66 out of 100 coal plants tracked by Central Electricity

Authority) were having critical coal stocks meaning less than 7 days of coal stock. Recovering from such a dire situation, today not a single power plant in the country is facing critical coal stock level.

While working hard to provide electricity to all, the Government has made clean energy a priority. It has set ambitious target to achieve 175 GW energy through renewable sources of energy, which include 100 GW of solar energy.

The new Government has focused on holistic and long term structural improvements in the sector, with a focus on achieving 24X7 power for all. The health of the power sector is borne out by the growth numbers. As per the Index of Industrial Production (IIP), electricity grew at 9% in October while Coal India Limited's output rose 9% in Apr-November. In 2014-15, Coal India has increased coal production by more than the increase in the last four years combined. As a consequence, imports plummeted 49% in November vs last year. The growth of generation from coal based stations during 2014-15 was 12.12%, which is the highest ever. The crisis arising from cancellation of 214 coal blocks by Hon'ble Supreme Court was turned into an opportunity through transparent e-auctions, all of whose proceeds go to States especially the less developed States in East India.

A capacity addition of

22,566 MW was achieved in the last year which is the highest ever. The peak shortage has reduced from 11.9% in 2008-09 to 3.2%, the lowest ever. Energy deficit during the current year has also reduced from 11.1% in 2008-09 to 2.3%, the lowest ever in the history of India.

On transmission front, there used to be a lot of constraints in supplying power from surplus states to deficit States. Efforts were made to expeditiously synchronize the Southern Grid leading to 'One Nation, One grid, One Frequency'. The Available transfer Capacity (ATC) during 2013-14 was only 3,450 MW which has been increased by 71% to 5,900 MW this month.

Powering India's Growth Coal, Scheme, Development, Rural Development, Electricity, LED, UDAY

In terms of fixing the weakest link in the power value chain, **UDAY** (Ujwal DISCOM Assurance Yojana) has been rolled out to tackle past, present and potential future problems of the sector. UDAY was developed through a bottom up approach with extensive consultations at the highest levels of States (CM, Chief Secretaries, Principal Secretaries, DISCOM MDs etc.), Bankers, regulators etc. While addressing DISCOMs' debt trap, UDAY delineates a path for sustainable operational improvement for DISCOMs. Government is also taking a number of initiatives to reduce cost of power. This is expected to

result in all the DISCOMs becoming profitable by 2018-19. A budgetary hard-stop under UDAY provides a permanent resolution to DISCOM issues and combined with a collaborative approach, focus on improving efficiency and reducing cost of power, distinguish UDAY from previous attempts to reform the sector.

Areas like energy efficiency have seen dynamic growth with more than 75% reduction in LED bulb prices and distribution of more than 4 crore bulbs in less than one year. The target of replacing every single bulb with an LED bulb is on track with 77 crore bulbs to be distributed by 2018.

The domestic and streetlight LED bulb programmes will help reduce the peak-load demand by nearly 22 GW, save 11,400crore units of electricity annually and bring about a reduction of 8.5 crore tons in carbon dioxide emissions every year. Setting up 22 GW capacity may have been hailed as a monumental achievement but it takes a different perspective to appreciate the avoidance of such investments while preserving the environment.

Foundation Stone of Delhi-Meerut Expressway laid

The Prime Minister, Shri Narendra Modi on 31st December unveiled a plaque to mark the laying of the foundation stone of the Delhi-Meerut Expressway at Sector-62 in Noida.

pollution. Noting the people's aspirations for development, the Prime Minister said good roads were one of the first pre-requisites for development. 

eligion has been the soul of India. As Swami Vivekanand put it: "In Every nation you will have to work through their methods. To every man you have to speak in his own language. If you want to speak of politics in India, you must speak through the language of religion."

The intention of both was to destroy Hinduism through English identity crisis in their souls 'the educated elite nurtured a major identity crisis in their souls for several generation.' This English education, writes Dr. Paulos, has 'culturally castrated' India. The key factor, he says, in restructuring the economy to make it strong, and restoring cultural vitality of the nation, can be nothing but the human factor and people's identity. Basically, the Sangh Parivar is a national striving in that direction.

Netaji Subhas Chandra Bose

Tubhas Chandra Bose was born on 23 January 1897 Cuttack, Orissa Division, Bengal Province, to Prabhavati Devi and Janakinath Bose, an advocate. He had a distinguished educational career and always topped the list. He went to England and there he competed for the Indian Civil Service, standing first. But the glamour of Indian Civil Service did not hold his heart. He was burning with a patriotic zeal to serve Mother India. He resigned the I.C.S. within a year and became a soldier in the struggle for India's freedom.

He was a man of daring schemes and unflinching determination. His self-discipline and spiritual inspiration were remarkable. Destiny had cut him out for great things. He never hankered after fame, ease, comfort, money and family. He cheerfully renounced all as if to fulfill a mission for which he was born and destined.

In the beginning, he was an ardent follower of Gandhi. With the speed of lightning, he rose from one distinction to another. In 1938, he became the President of the Indian National Congress for the second time. As the President of the India National Congress, he had some sharp



differences with Gandhi. The rift between the two widened.

He resigned from the Congress and founded the Forward Bloc. He never slackened his duty towards India. The World War II had, about this time reached a critical stage. The Allies were having a difficult time. This foremost adventurer and revolutionary ran away from his home in Kolkata eluding the police.

He travelled to Afghanistan, in the guise of a Pathan. He managed to reach Germany and then Japan. He organized in Malaya his 60,000 strong I.N.A. to fight India's war of independence from outside India. He said to his soldiers, 'Give me blood and I will give you freedom.'

His stirring call to his soldiers was 'Delhi chalo'.

The exploits of the I.N.A. were on the lips of every Indian. It was India's first national army to plant the tricolour flag of India on the liberated soil of Manipur and Kohima. With the fall of Japan, he was reported dead on August 19, 1945 but the incident continues to be shrouded in mystery.

Netaji was a born leader of men. He was cast by nature in the mould of greatness. He fought the forces of evil with the straightforwardness and boldness of a missionary. His gifts were God- given. He was cut out by nature as the pre-appointed agent for great things. Few men can equal him in the absolute purity of character, consistency of principle and grim determination to see things through. He refused to be cowed down by any person.

He clung to, little caring for the consequences, to what he considered to be right, morally and ethically. "I stand for truth; I fight for truth and I shall die for truth," said Netaji in one of his memorable speeches Singapore. He did not fear even death. "I am immortal till my work is done", he used to say. May the soul of the mighty architect of India's liberation lead us and show us light in the forward march of our country.

Stray thoughts after the winter session

he Winter Session of Parliament has just concluded. The Winter Session gives rise to a few legitimate thoughts which I must share.

On Parliamentary Democracy:

Parliamentary Democracy has been India's foremost strength. Different shades of political opinions, regions, States, communities, tribes, all find their way in the decision making process in Parliament. Parliamentary protests are not unheard of in India. In extreme cases there are precedents of disturbance in the past. But the last two sessions have witnessed a clear stand of the Congress Party that Parliament shall not be allowed to function. Most of the congress leaders, in private, have expressed helplessness over the decision of their leadership that Parliament must be disturbed continuously. The moot question which arises for the Congress Party is, 'how does India legislate?' The Standing Committee mechanism which worked exceedingly well since 1993, has been weakened in the Rajya Sabha, by the House repeatedly appointing Select Committees, questioning the opinions of the Standing Committee. If this tendency continues, successful institution of Standing Committee could be hurt. The

Government, therefore, has adopted an alternative option of a Joint Committee to consider the Bankruptcy Law. There are other options being suggested, such as to pass legislation without a Standing Committee or drafting laws in a manner to fit them into the definition of Money Bills. The latter two are not preferred options. The Congress Party leadership must seriously explore that its disproportionate irrational approach in dealing with Parliament is hurting institutions. If Pandit Nehru can be credited in the initial years of our democracy of having laid down of healthy precedents being established, the current generation in control of the Congress Party will find a place in history of having weakened what their ancestors established. Has the country not lost out by delaying the GST since the last year's Budget Session? How far is it desirable to pass important legislations on the last day without discussion? Statistically, we have passed a law. But has Parliament applied its mind to the law? Vulgarity:

Is vulgarity the new norm of Indian politics? I hope not.

Some months ago a few Members of the Bharatiya Janata Party made statements which were not appreciated even by the Party. The Party President cautioned them and advised them to refrain from making such statements. The result of the caution are visible.

about statements made by the Hon'ble Chief Minister of Delhi about the Prime Minister and others, both inside and outside Delhi Assembly? If any functionary of the Government of India were to use such language, it would witness a nationwide outrage. People in positions are expected to act with restraint. They cannot be outlandish. Vulgarity is not a right available to them. The political discourse cannot be couched in vulgar language. Falsehood delivered with vulgar overtones is not a substitute Lumpenisation of public discourse can never be high point of politics. Functionaries of the Delhi Government and its supporters have lowered the level of political discourse. They rely heavily on general falsehood without ever stating the specifics. The Aam Aadmi Party's success in Delhi seems to have misled the Congress Party that vulgarity brings votes. Indian public opinion has a sense of fairness. It is time that public opinion expresses its outrage against the lowering of the level of public discourse. ■

Shri Modi said, in India, cardiovascular diseases, cancers, chronic respiratory diseases, diabetes, and other Non Communicable Diseases are estimated to account for 60% of all deaths. We face the tragedy of productive lives cut short and families that must deal with untimely loss; the huge toll on the economy; and, the excessive burden on the over-stretched health system.

Some studies have estimated that India stands to lose about 4.58 trillion dollars before 2030 due to non communicable diseases and mental health conditions. So, we must address the question of psychological state of our existence as much as we try to advance our physical and material life. This is where the role of Yoga is paramount. Across the world, there are stories moving of transformed lives and rekindled hopes due to Yoga he added.

The PM said we are no longer satisfied with just preventing and managing diseases. People now demand promotion of wellness, which is a healthy balance of the mind, body and spirit. We now increasingly hear voices calling for holistic treatment, which means dealing not just with the immediate ailment, but with the complete person, physically, psychologically, socially, and spiritually.

Traditional Indian systems are rooted in looking at human beings in totality. He said Modern systems of medicine have transformed healthcare: screening, detection and diagnosis of diseases. Use of technology has reduced barriers to accessing health care, and improved our understanding disease patterns. Breakthroughs in medicines and vaccines have helped conquer and contain many diseases. But, as our understanding of its limitation and its side effects have grown, as we experienced the growing costs of modern medicine systems, we have begun to look traditional bevond to systems, not just in India, but in other countries as well.

Their popularity is growing. Yoga is now a global heritage. And, the world is embracing traditional Indian medicine with great enthusiasm. So, we look to you at this conference to define the path forward in the service of humanity Shri Modi said.

### A New Approach to Development

ne of the biggest problems for us has been that our development model has been supply-driven. A scheme has been prepared in Lucknow, Gandhi Nagar, or Delhi the same is attempted to be injected. We want to shift this model from supply-driven to demand driven through *Adarsh Gram*. There should be an urge developed in the village itself.

All we need is to change our mind set. We need to unite people's hearts. Normally MPs are engaged in political activities, but after this, when they will come to the village, there will be no political

Saansad Adarsh Gram Yojana (SAGY) was launched on 11th October, 2014 with the aim to translate the comprehensive vision of Mahatma Gandhi about an ideal Indian village into a reality, keeping in view the present context. Under SAGY, each Member of Parliament adopts a Gram Panchayat and guides its holistic progress giving

importance for social development at par with infrastructure. The 'Adarsh Grams' are to become schools of local development and governance, inspiring other Gram Panchayats.

By involving villagers and leveraging scientific tools, a Village Development Plan is prepared under the leadership of Member of Parliament. Thereafter

detailed project reports are prepared and submitted by departments to the state government. State Level Empowered Committee (SLEC) reviews, suggest changes and give priority allocation of resources. As of now, 21 Schemes have been amended by various Ministries / Departments of Government of India to give priority to SAGY Gram Panchayat projects.

At district level, monthly review meetings are conducted for each Gram Panchayat under the chairpersonship of Member of Parliament. Each projects are reviewed in the presence of representatives of the participating line departments and the progress is updated to the state government. It is expected that each Member of Parliament will spearhead development of one Gram Panchayat as a model one by 2016, then two more by 2019 and thereafter five more by 2024. 696 GPs have been

adopted by MPs across the country so far.

Each District Collector has nominated a Charge Officer of sufficient seniority to coordinate the implementation at the local level who will be fully responsible and

accountable for the implementation. Ministry of Rural Development organised training programmes for 653 Charge Officers at 9 regional locations across India. A National Workshop was organised on 23rd-24th September, 2015 at Bhopal by Ministry of Development, where MPs, State Governments, District Collectors, Gram Pradhans from across all States were invited. The selected Good Practices by National Level Committee of the Ministry of Rural Development were presented through a detailed exhibition so that similar good practices could be adopted in SAGY Gram Panchayats. The Ministry has also developed 35 indicators as 'Panchayat Darpan' to monitor the progress of the SAGY Gram Panchayats.

Some Success Stories:

In Laderwan village, Block Trehgam, District Kupwara, Jammu & Kashmir, the major activity of the people is agriculture. To promote scientific agriculture, the mobile numbers of 379 their agricultural produce.

Maravamangalam, situated in Sivaganga district, Tamil Nadu was chosen as the Adarsh Gram by the Member of Parliament (Rajya Sabha), Dr. E.M. Sudarsana Natchiappan. The Member of Parliament identified the for potential areas improvement and to promote rural livelihoods. Coir, leather and coconut trainings for the communities were envisaged and promoted. The MP organised several awareness

farmers were linked with the Krishi Vigyan Kendra (KVK). The KVK disseminates sms messages on weather forecasts and messages on the recommended package of practices for specific crops at critical stages of crop growth. This has been undertaken under the guidance of the Member of Parliament, Shri Muzaffar Hussain Baig. As a result, farmers now get regular agro-advisories on their mobiles. These include critical messages on scientific sowing practices, soil testing, crop protection, agronomic post-harvest practices, technologies and market information. This enables people to take informed decisions relating to crop production and marketing

programmes with the support of the District Administration and Alagappa University. He also roped in specialist training partners for imparting training to the people with the support of the Coir Board of India, Coconut Development Board of India and Central Leather Research Institute.

He coordinated with the training institutions for initiating a two months Coir training programme with the objective to educate the people in becoming successful entrepreneurs. 120 women for coir training, 112 people for leather training and 27 men for coconut Training were enrolled in the training programmes. After the trainings are completed, all

efforts will be made by the district administration and the training partners to provide financial assistance to the successful trainees for starting their own social enterprise and support their livelihoods.

The Member of Parliament Shri Bidyut Baran Mahato in his adopted Gram Panchayat of Bangurda realised that very minimal efforts were being taken with regard to health and hygiene of adolescent girls in remote and inaccessible villages in East Singhbhum, Jharkhand. There is high prevalence of Anaemia and other ailments, especially among women and adolescent girls. In order to address this, he initiated a series of health camps specifically targeted towards the adolescent girls. The health camps were organised in the Kasturba Gandhi Balika Vidyalaya, where more than adolescent girls screened. As a result, many of the girls were found to be suffering from various gynaecological diseases, urinary tract infection and skin diseases, which hitherto, were suppressed by them owing to socio-cultural taboos.

It was also found that most of these ailments were related to unhygienic lifestyle and filthy surroundings. Interventions are underway to create awareness on personal hygiene among the adolescent girls and women. This will be a sustained intervention to be carried out regularly in the villages.

### Mufti Mohammad Sayeed no more

Jammu and Kashmir Chief Minister Shri Mufti Mohammad Sayeed, died in New Delhi on 07 January, 2016. Shri Sayeed, 79, breathed his last at AIIMS after remaining on ventilator for the past few days.

A Congressman till 1987, Shri Sayeed left the party and joined the ranks of V P Singh to become the only Muslim Home Minister when he was inducted into the cabinet of the National Front government in 1989.

Shri Sayeed, who was Chief Minister from 2002 to 2005 in coalition with Congress, played a leading part in PDP and BJP coming together to form the first PDP-BJP coalition government in the state.

The mortal remains of Shri Sayeed were flown in a special Indian Air Force plane to Srinagar and were buried at his ancestral village in Bijbehara in South Kashmir. Prime Minister Shri Narendra Modi and Home Minister Shri Rajnath Singh paid tributes to Shri Sayeed at the Palam technical area before the body was flown to Srinagar.

The Central Government announced that the national flag will be flown half-mast across the country as a mark of respect to the departed leader, who has also been accorded a state funeral. He is the second J&K Chief Minister to die in office, the first one being Sheikh Mohammad Abdullah who died on September 8, 1982. Shri Sayeed is survived by his wife, three daughters and a son. Jammu and Kashmir government has declared a seven-day mourning. Flags will be flown at half mast.  $\blacksquare$
